

KOMİLİ OLIVE AND OLIVE OIL INSTITUTE USER & PARTICIPANT INFORMATION TEXT ON THE PROTECTION OF PERSONAL DATA

Pursuant to Article 10 titled "Data Controller's Obligation to Inform" of the Personal Data Protection Law No. 6698 ("KVKK" or "Law") published in the Official Gazette dated April 7, 2016 and numbered 29677, which aims to protect the fundamental rights and freedoms of individuals in the processing of personal data, and the Communiqué on the Procedures and Principles to be Followed in Fulfilling the Obligation to Inform published in the Official Gazette dated March 10, 2018 and numbered 303577, we hereby aim to inform you about your personal data processed by our Company **Bunge Gıda Sanayi ve Ticaret A.Ş.** ("**Bunge**" or "**Company**") with this Clarification Text.

1. IDENTITY OF THE DATA CONTROLLER

2. PROCESSED PERSONAL DATA

The following personal data is processed within the scope of your relationship with Bunge;

- (i) **Your Identity Information:** Name, surname;
- (ii) **Contact Information:** e-mail, phone;
- (iii) **Your Audiovisual Records:** photos, videos.

3. PURPOSES OF PROCESSING PERSONAL DATA

Your personal data obtained within the scope of your relationship with Bunge is processed for the following purposes:

- Registration and updating of user & participant information,
- Evaluating and responding to your questions, requests and opinions regarding Komili Olive and Olive Oil Institute,
- Sharing of your visual and audio recordings on KOMİLİ social media accounts managed by our Company and use in other non-commercial communication materials, in order to promote the activities of Komili Olive and Olive Oil Institute and to increase its visibility,
- Evaluations regarding your applications submitted to the Company within the scope of exercising your rights specified in Article 11 of the Law regarding your personal data processed by our Company regarding Komili Olive and Olive Oil Institute and finalizing them in accordance with the legislation and carrying out the necessary transactions within

this framework,

- Management of user & participant relations,
- Planning and execution of user & participant satisfaction and corporate communication activities,
- Retention of personal data during the general statute of limitations in order to constitute evidence in possible future disputes,
- Receiving, evaluating and processing your inquiries and complaints.

4. TRANSFER OF PROCESSED PERSONAL DATA

Your personal data may be transferred to third party real and legal persons, service provider companies and their officials, business partners, legally authorized public institutions and legally authorized private persons within the scope of the provisions of the Law regarding the transfer of personal data and the transfer of personal data abroad, for the purposes set out in Article 3 of this Clarification Text within the scope of the provisions of the Law regarding the transfer of personal data and the transfer of personal data abroad, for the purpose of providing electronic mail exchange of your personal data if you give your explicit consent, within the framework of the personal data processing conditions and purposes specified in Articles 8 and 9 of the Law.

5. METHODS AND LEGAL REASONS FOR COLLECTING PERSONAL DATA

Your personal data is collected during the establishment of your legal relationship with Bunge and the continuation of the said relationship, within the scope of fulfilling the above-mentioned Purposes, through online application form, call center, mobile applications, text messages, e-mails and interviews and forms in cases where you contact our Company in physical environment.

Your personal data is collected and processed by our Company for the following purposes and legal grounds based on the personal data processing conditions specified in Article 5 of the Law:

Based on the legal ground that the processing of personal data of the parties to a contract is necessary, provided that it is directly related to the conclusion or performance of the contract;

- Registration and updating of user & participant information,

Based on the legal ground that it is clearly stipulated by law and that it is mandatory for the data controller to fulfill its legal obligation;

- Evaluations regarding your applications submitted to the Company within the scope of exercising your rights specified in Article 11 of the Law regarding your personal data processed by our Company regarding Komili Olive and Olive Oil Institute and finalizing them in accordance with the legislation and carrying out the necessary transactions within this framework,

Based on the legal ground that data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject;

- Management of user & participant relations,
- Planning and execution of user & participant satisfaction and corporate communication activities,

- Evaluating and responding to your questions, requests and opinions regarding Komili Olive and Olive Oil Institute,

Based on the legal ground that data processing is mandatory for the establishment, exercise or protection of a right;

- Receiving, evaluating and finalizing your requests and complaints,
- Retention of personal data during the general statute of limitations in order to constitute evidence in possible future disputes.

In the presence of your explicit consent;

- Sharing of your visual and audio recordings on KOMİLİ social media accounts managed by our Company and use in other non-commercial communication materials, in order to promote the activities of Komili Olive and Olive Oil Institute and to increase its visibility.

6. RIGHTS OF THE DATA SUBJECT WHOSE PERSONAL DATA IS PROCESSED

Pursuant to the provisions of Article 11 of the Law, you have the following rights in relation to your personal data:

- Learn whether personal data is being processed,
- Request information if their personal data has been processed,
- Learn the purpose of processing personal data and whether they are used for their intended purpose,
- Know the third parties to whom personal data are transferred domestically or abroad,
- Request correction of personal data in case of incomplete or incorrect processing,
- Request deletion or destruction of personal data,
- In case of correction, deletion or destruction of personal data, request notification of these transactions to third parties to whom personal data are transferred,
- Oppose the use of personal data for purposes that are prejudicial to the person concerned, through the use of automated systems for the analysis of the data processed,
- Demand compensation for the damage, In case of damage due to unlawful processing of personal data.

7. IF YOU WANT TO CONTACT US FOR YOUR RIGHTS AND DEMANDS

In accordance with your legal rights stipulated in the relevant law and other legislation, you can submit your requests to our address above with a petition by hand or through a notary public. Also, in accordance with Article 5 of the "Communiqué on the Procedures and Principles of Application to the Data Controller", you can send it to **bungegida@hs03.kep.tr** or **beu.turkey.dataprotection@bunge.com** by using registered electronic mail (KEP) address, secure electronic signature, mobile signature. A sample application form is attached.

Applications to be made within this scope will be accepted following the identity verification to be made by us, and your requests will be finalized as soon as possible and within 30 days at the latest, depending on the nature of the request. In case of a written response to the application, no fee will be charged up to 10 pages, and a transaction fee of 1 Turkish Lira may be charged for each page over 10 pages. If the response to the application is given in a recording medium such as CD, flash memory, etc., a fee may be charged in the amount of the cost of the recording medium.
